# Tiger found dead in MP's Bandhavgarh reserve; territorial fight suspected

**PRESS TRUST OF INDIA**  
**UMARIA (MP), MAY 12:** A tiger has been found dead in the Bandhavgarh Reserve in Madhya Pradesh's Umaria district, with the authorities suspecting it was killed in a territorial fight, officials said on Tuesday. Security personnel at Dhamdhama Camp in the Khitauli range of the reserve reported hearing sounds of tigers fighting around 6.30 am on Monday, field director Dr Anupam Sahay said. A patrol team later searched the area and found the

carcass. A preliminary examination indicated the tiger died in a clash between big cats. The carcass bore attack marks, but all organs were intact, the official said. The tiger, nicknamed Pujari, was around eight years old and reportedly known as B1, often fleeing upon sighting it, he said.
